Friends of the Randolph Public Library Board Meeting January 13, 2021 Meeting Minutes

I. Call to Order

Anne Forsyth called to order the meeting of the Board of the Friends of the Randolph Public Library at 9:00 AM EST on January 13th, 2021. This meeting was held virtually, via Zoom.

II. Attendance & Introductions (In order)

- Michelle Cormier Treasurer

III. Librarian Introduction

Yvonne expressed gratitude for the new group and gave an overview of how running the library is a concerted group effort – the Trustees, the Friends, and the Librarian. Yvonne also expressed the importance of keeping the library going! She referenced the materials shared before the meeting but acknowledged that the new board members will likely have questions.

IV. Financial Overview from the Treasurer

Michelle gave an overview of current finances and touched upon several questions asked by the group. Yvonne also contributed information on some of the elements below.

- Yes Fiscal year is the calendar year. As of 12/31/2020, we have closed the year for 2020.
- We have three filings that need to be completed:

• Separate, restricted fund set aside in memory of Meg Meiklejohn: total is \$5,005.

- Purpose of the fund has yet to be established, so we'll need to determine the purpose (along with family's input) in order to spend the funds.
- Breakdown of Annual Expenses:
 - Movie License: \$146 in 2020, but haven't had a bill for 2012
 - o Filing Fee: \$25 paid to the paid to state of NH for reactivating our corporation
 - Programs: Part of the library request since the Library budget does not have a Programming line item in their budget. Past programs/expenses include:

- Summer Reading Program supplies
- DVDs for Fred Hubbard Collection: ~\$300-400 per year, but not much purchased in 2020
- Petty cash: ~\$100
- Unrestricted "grant" from donor (Donor-Advised Fund from Vanguard): Anne recommended that we list it as a donation (Question from Catherine)
 - No difference to the donor putting the money in Friends account versus Library checking account

- Michelle to pull together an excel of financials/expenses for the past 5 years so that the newer board members can get a sense of annual cash flows (Question from Anne)
- No preference on a donation going "to the Friends" versus "to the library" it ultimately all goes to the Library ultimately (Question from Kayla)
- Urgent need for funds now? (Question from Catherine):
 - Yvonne responded that the library will need ~\$200 for the Great North Libraries programming (4 program for the price of 1).
 - Yvonne will need funds for Children's Summer Reading program likely over Zoom
 - Anne proposed that we'll put an agenda item titled "Authorization for Expenditures" and any request will be put to a motion and approved in the minutes
 - In between meetings, we can approve a motion via email and add it to the next month's meeting minutes

V. Meetings

- Frequency:
 - Anne proposed a monthly meeting, especially in the winter months
 - Michelle suggested meetings as-needed, not necessarily monthly
 - o Compromise: we'll start with meetings for February and March, then TBD on April
 - Treasurer's report could also be provided electronically
- Timing:
 - Agreed on 2nd Wednesday of each month at 9 AM EST

VI. Trustees

- Treasurer for the library is member of the Trustees currently Rhonda Stitt
- Trustees & Librarian cannot serve on the Board of the Friends
- Upcoming meeting is the Trustee meeting on Monday
 - o Budget due prior

VII. Membership of the Friends

Michelle & Yvonne gave an overview of the current membership – there has never been a formal process to "be" a Friend, but many people consider themselves Friends. Yvonne has a contact list of people, which was used to elect the new board members, and Michelle has one of the original contact lists. We should revisit these lists. NOTE: Edith Tucker is very involved and wants to be a contributing Friends member.

An important distinction made by Michelle: We are not a membership organization – the membership is not empowered to run the organization. The board runs the organization. We can make decisions as long as they are in the best interest of the library.
