 - January 3, 2024 RPL Doug Arion from Mountains of Stars will present on the April total solar eclipse *Darkness in the Daytime*. In person at WMCC or via Zoom, or at Watch Party at RPL
 - Feb 7 BPL, Matt Maloney from Tin Mountain will present *Backyard Astronomy throughout the Year*
 - Mar 4 WMCC, John Holt on space travel
 - April 3 WMCC, Maine Mineral & Gem Museum
 - May 1 GPL, Michael Francis from Humanities to Go to present *Galileo Galilei, the Starry Messenger*, at Medallion

 - History Theme: Invite Judy Hudson to present her new book on the history of Randolph since the 175th birthday. Twenty minutes with probable slides/visuals. We'd use the Town Hall and offer light refreshments (birthday cake, cupcakes, cookies funded by the bicentennial committee). This is dependent on Judy's availability and whether the committee has other plans for the book's presentation.
- Separately, Yvonne took notes for potential library programming:
 - o Great to have a bee pollinator program
 - Randolph Old and New book discussion
- Welcome to Randolph Open House
 - Discussion around the postponed Open House: Yvonne wouldn't want to do an open house that is exclusive. If we wanted to invite the new folks, that could be an opportunity, but it should be open to all. Group also thought it would be a way to capture/check off folks on the Welcome to Randolph list
 - o ACTION: Yvonne will talk to Anne, and she will let us know about an open house
- Library After Hours
 - River movie & potluck will be part of the conversation about an after hours committee

 - o Initial discussion around Story walk would need at least 20
 - o Glen Road/Forest Service they have a permanent installation
